• Vision	Payroll deduction	Upon employment	Optional vision care plan allows employees to purchase frames and lenses at a discount from selected vendors. Family or single coverage.
• Dental	Payroll deduction	Upon employment	Optional dental care plan allows employees to acquire dental services from preferred providers. Family or single coverage.
• Life	University	Starts first day of month after employment date	University provides \$12,000 term insurance. You may purchase up to \$600,000 additional; Spouse and dependent
