- Documentation of the student qualifying for a state tuition or other state benefit accorded to the children or other family members of a public safety officer consistent with the definition in 42U.S.C. 3796b, or as a fire police officer; or
- Other documentation from a credible source that describes or reports the circumstances of the death and the occupation of the parent or guardian.
